

# TERMS AND CONDITIONS FOR THE 12TH "CALIER BEEKEEPING" PHOTO COMPETITION

**Laboratorios Calier, S.A.**, with registered office at C/ Barcelonès 26, 08520 Les Franqueses del Vallès, Barcelona, Spain, and C.I.F. tax ID code A-08291924 (hereinafter, "Calier"), has organised the 12th "Calier Beekeeping" Photo Competition, to be governed in accordance with the following terms and conditions:

# **Participants**

Any natural or legal person **resident in Spain, France, Italy or Portugal** may enter the competition. Calier and other Grupo Indukern, S.L. company employees and immediate family members are not eligible to enter.

#### Presentation

Each participant may submit **up to 3 photographs** and win 1 prize only. Please send photos to the following email address: **fotoapicultura@calier.es**.

Photos must have a minimum resolution/size of 200 pixels per inch (p.p.i.) / 1500 x 2300 pixels. Photos that do not meet these specifications may be disqualified.

Photos the jury considers offensive to the dignity of people or animals, as well as those that include watermarks or any identifying text or information, shall not be accepted.

Each photo must be accompanied by the following information:

- Photographer's name
- Contact email address
- Contact telephone number
- Title of photo
- Place where photo was taken

#### Theme

The competition has 3 categories:

- **General:** On the theme of beekeeping and in particular, photographs of *Apis mellifera iberica*.
- **Beekeeping:** On the theme of beekeepers, beekeeping and their environment.
- Special: On the theme of bee health, bee management and pollinating insects.

# Photographs must be original and unpublished.

#### Territorial scope

The competition shall take place in Spain and any individual or legal entity resident in Spain, France, Italy or Portugal and over 18 years of age may enter.

#### Time scope and term for submission



The term for receiving photographs shall begin on 1 April 2025 and end on 31 October 2025.

The jury's decision shall be made public on 1 December 2025 over the website: <a href="https://www.fotoapiculturacalier.es">www.fotoapiculturacalier.es</a>.

Winners shall also be notified directly.

# Jury

The jury shall have three members:

- Antonio Gómez Pajuelo (Biologist and beekeeper)
- Federico Casillas Santos (Calier)
- Manuel Gonell Galindo (Graphic designer)

The jury shall decide on all competition prizes and its decision shall be final.

#### **Prizes**

A total of 3 photographs shall be awarded from the 3 categories\*:

- 1 winner from the General Category
- 1 winner from the Beekeeping Category
- 1 winner from the Special Category

Together with the 3 winning photographs, 10 additional photos shall be selected to be part of the "Calier Beekeeping" 2025 Calendar.

\*In the event of the Beekeeping or Special category being deserted, a second prize shall be awarded in the General category. This means there shall always be three winners.

The following prizes are established:

The winner of each category can choose from:

- 1. Mini-projector with wifi and bluetooth (or similar) and diploma.
- 2. Acer Swift 3 computer (or similar) and diploma.
- 3. Apple iPad (10.2 inch 64 GB) (or similar) and diploma.

# **Image rights**

Participants certify that:

<sup>\*</sup>Prizes cannot be awarded across two consecutive editions.



- The photos they enter in the competition do not impact third-party image rights, or that they have obtained the necessary authorisation for possible reproduction or exhibition.
- The relevant authorisations of the persons appearing in the photographs have been obtained, as well as that of the owners of any animals that appear.

Participants shall be liable for third-party claims arising from image and intellectual property rights.

# Rights of use

Copyright over the winning photos shall belong to the authors. All participants agree to transfer the exploitation rights of their photos for use in the "Calier Beekeeping" Photo 2026 Calendar, the Calier website or other publications, including for promotional purposes, without seeking compensation in return for their use.

## Awards ceremony

The live awards ceremony shall be held during the International Beekeeping Fair in Pastrana (Castilla-La Mancha) in March 2026.

Calier shall contact the winners to inform them of the exact date and time in February 2026.

Once the competition has ended and the jury's decision has been duly notified to the winners, all entries shall be published on the www.fotoapiculturacalier.es website.

## **Tax**

Awards may constitute capital gains and shall be subject to the applicable income tax regulations at the time of obtaining them.

## Acceptance and deposit of the terms and conditions

By entering this competition you agree to the terms and conditions and to the jury's decisions and selection of winners. If this is not the case, you must not enter the competition.

The terms and conditions are published on the website www.fotoapiculturacalier.es.

Calier reserves the right to cancel, extend, shorten or modify the competition at any time if circumstances force it to do so, without having to justify the decision and without any liability being claimed as a consequence, provided the rights acquired by the participants are not prejudiced. In these situations, Calier shall communicate this to the participants through the means it deems appropriate, as well as to the rest of the possible contestants.

Any claims in relation to the promotion, awards ceremony, etc. must be made within sixty (60) calendar days from the last day of the competition.



# Waiver of liability

By way of example, but not limited to this, Calier accepts no responsibility for possible loss, theft, delay or any other circumstance attributable to third parties that may impact this competition, nor for the use made by the participant with respect to the award obtained from it. The company assumes no responsibility for any damage or harm of any kind that may be caused to participants, winners or third parties.

Calier accepts no responsibility in cases of force majeure or unforeseeable circumstances that could prevent the competition from taking place or the full or partial enjoyment of the prize. If the competition cannot go ahead, either due to the detection of fraud, technical errors or any other reason beyond Calier's control that affects the normal running of the competition, Calier reserves the right to cancel, modify or suspend the competition, including the entry website.

## Data protection

Your data shall be processed in accordance with the provisions of the General Data Protection Regulation (EU) of 27 April and other applicable legislation (Organic Law on Data Protection, among others).

The data shall be included in a file for which Laboratorios Calier, S.A. is responsible and owner, and the company may process it exclusively for the purpose of managing the competition, the awards ceremony and/or for advertising or commercial prospecting purposes by any means, including email, according to the preferences indicated in the registration form for this competition.

In no case does this involve processing data other than the data indicated. This procedure is based on the contractual execution of participation and acceptance of these terms and conditions, since once you have freely and voluntarily agreed to enter the competition, you must accept these terms and conditions and the processing of your personal data essential for correct execution of the competition.
